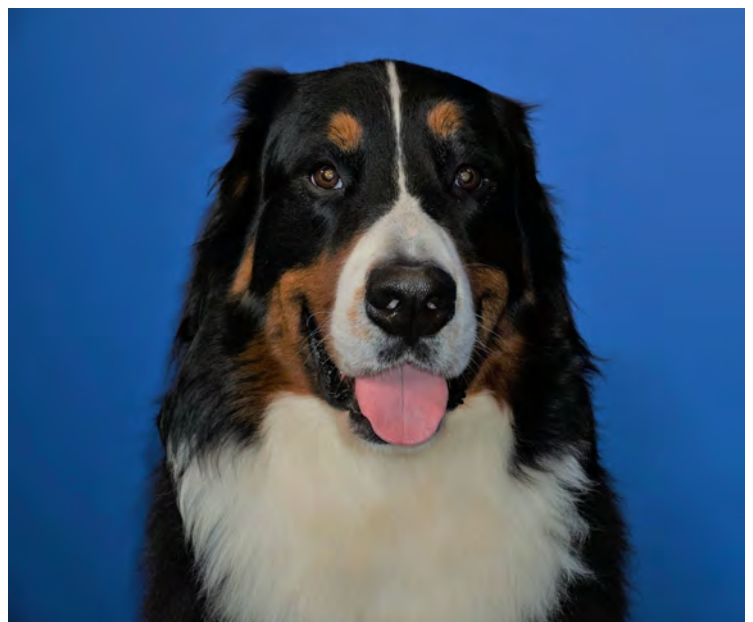

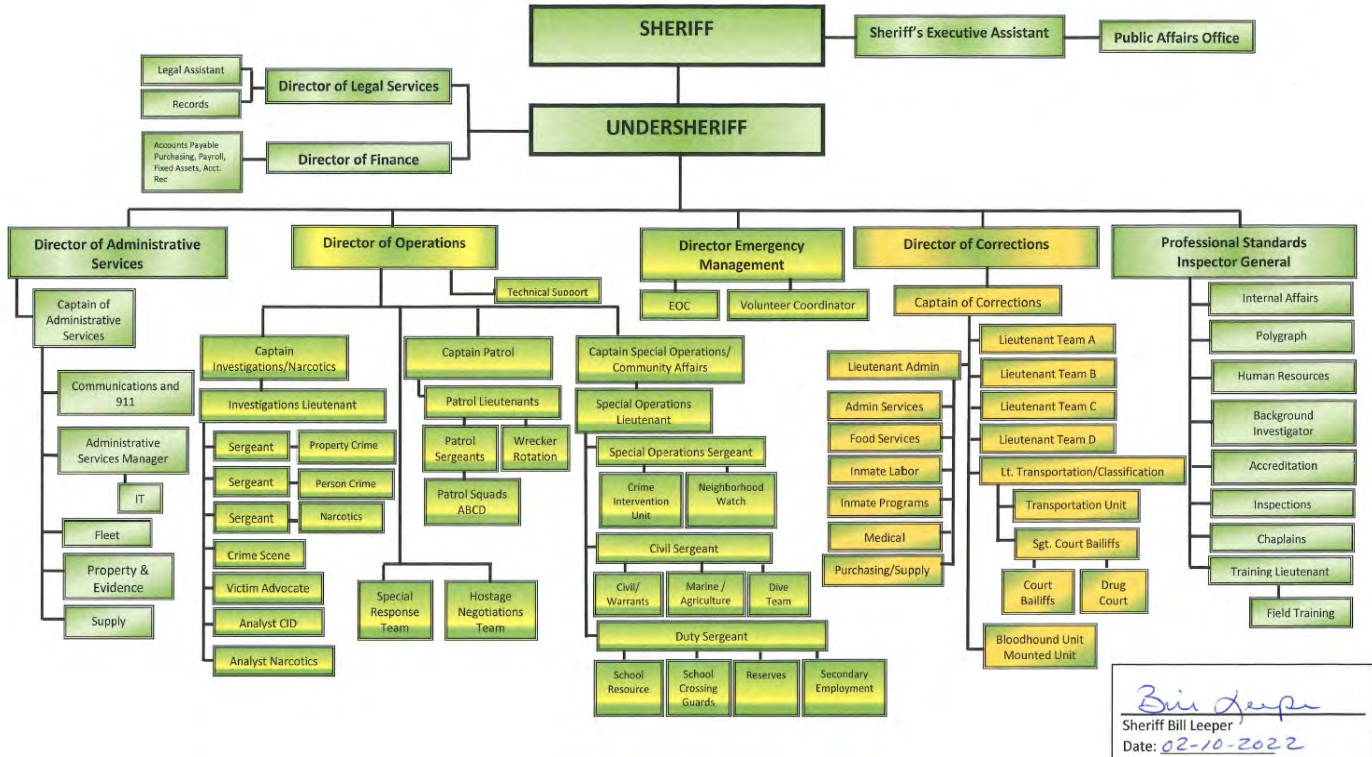

NCSO IS A TRIPLE ACCREDITED LAW ENFORCEMENT AGENCY. THAT MEANS OUR LAW ENFORCEMENT, CORRECTIONS AND COMMUNICATIONS DIVISIONS MEET STANDARDS SET BY THE COMMISSION FOR FLORIDA LAW ENFORCEMENT ACCREDITATION. AN ACCREDITATION ASSESSMENT EXAMINES ALL ASPECTS OF THE NCSO, INCLUDING LOOKING AT POLICIES AND PROCEDURES, MANAGEMENT, OPERATIONS AND SUPPORT SERVICES. THE AGENCY HAS TO COMPLY WITH APPROXIMATELY 580 STANDARDS IN ORDER TO RECEIVE RE-ACCREDITATION STATUS. MANY OF THE STANDARDS ARE CRITICAL TO LIFE, HEALTH AND SAFETY ISSUES.

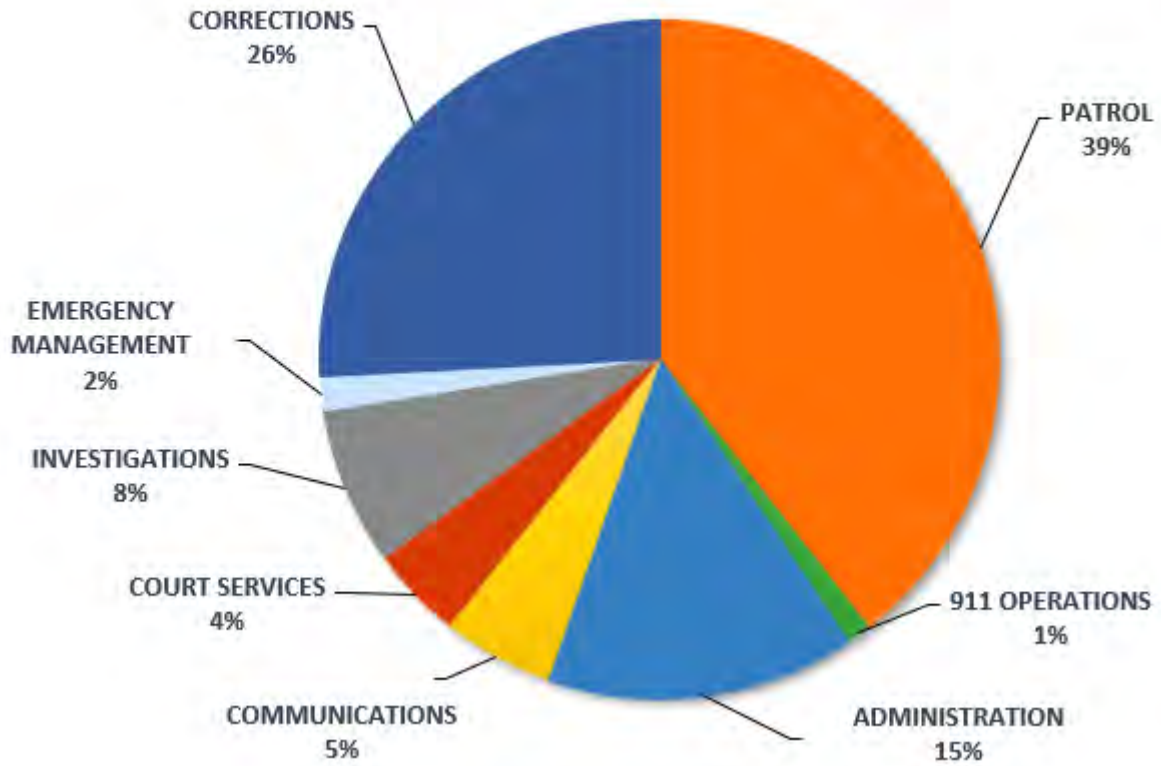

# Teen Academy



IN JULY 2022, OUR AGENCY HOSTED 35 TEENAGERS AS PART OF OUR SHERIFF'S TEEN CITIZEN ACADEMY. DURING THIS THREE DAY EVENT, TEENAGERS WERE ABLE TO HELP SOLVE A MOCK MURDER CASE BY UTILIZING NASSAU COUNTY SHERIFF'S OFFICE AGENCY-WIDE RESOURCES. DAY ONE STARTED WITH A LIVE SCENARIO FEATURING AN "ACTIVE MURDER CASE" ACTED OUT BY NCSO EMPLOYEES. THEY VISITED THE COURTHOUSE TO MEET WITH THE HONORABLE JUDGE ROBERT FOSTER AND THE ASSISTANT STATE ATTORNEY'S OFFICE SUSAN HAAG. DAY TWO BEGAN WITH PROCESSING EVIDENCE WITH OUR AG/MARINE UNIT AND DIVE TEAM, A SCENT TRACK FROM OUR K9 HANDLERS AND K9'S WHICH LED THEM TO THE SUSPECT'S VEHICLE. DAY THREE THE KIDS MET OUR HOSTAGE NEGOTIATION TEAM, SPECIAL RESPONSE TEAM AND OUR MOBILE COMMAND UNIT. THEN THE CADETS WERE AWARDED THEIR CERTIFICATE OF COMPLETION FROM SHERIFF BILL LEEPER.

# Teen Driver Challenge



TEEN DRIVER CHALLENGE IS A FREE COURSE DESIGNED TO HELP TEENS BOOST THEIR DRIVING SKILLS AND LESSEN THE CHANCES OF BEING INVOLVED IN A CRASH. THE PROGRAM WILL PROVIDE A MIXTURE OF CLASSROOM INSTRUCTION AND HANDS-ON DRIVER TRAINING. TEENS 15-19 ARE ELIGIBLE AND MUST HAVE A VALID FLORIDA OPERATORS LICENSE AND PARTICIPANTS MUST PROVIDE THEIR OWN CAR. A CURRENT COPY OF A DRIVER LICENSE, VEHICLE REGISTRATION AND INSURANCE IS REQUIRED. THE CLASS IS LIMITED TO 12 STUDENTS.



# D.A.R.E.



NASSAU COUNTY 5TH GRADE STUDENTS PARTICIPATE IN OUR D.A.R.E PROGRAM, WHICH IS TAUGHT BY DEPUTY LISA MCCUMBER. SHERIFF BILL LEEPER AND DEPUTY MCCUMBER REINFORCE GOOD DECISION MAKING SO THESE STUDENTS CAN LIVE A DRUG-FREE AND VIOLENCE-FREE LIFE. THESE IMPORTANT LIFE SKILLS WILL HELP CARRY THESE YOUNG STUDENTS THROUGH THEIR ADULTHOOD TO HELP THEM MAKE POSITIVE CHOICES. THE MISSION OF THE FLORIDA DRUG ABUSE RESISTANCE EDUCATION (D.A.R.E.) PROGRAM IS TO EQUIP THESE KIDS WITH TOOLS THAT WILL HELP THEM AVOID NEGATIVE INFLUENCES AND INSTEAD ALLOW THEM TO FOCUS ON THEIR STRENGTHS AND POTENTIAL.

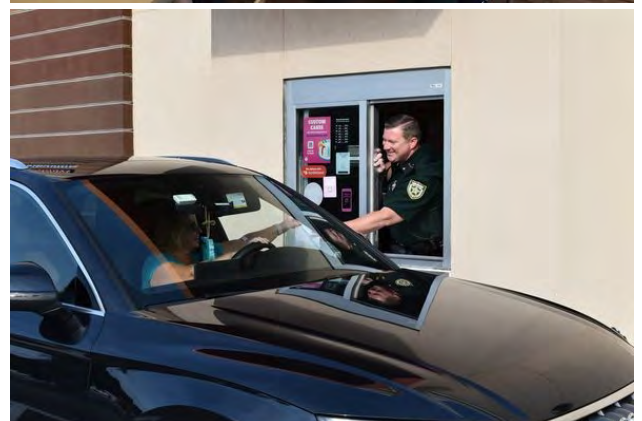

# Agency Improvement Committee

THE NCSO AGENCY IMPROVEMENT COMMITTEE MEETS TO OFFER SUGGESTIONS AND SOLUTIONS ON HOW TO IMPROVE THE AGENCY. SHERIFF LEEPER DEVELOPED THE COMMITTEE AFTER HE WAS SWORN INTO OFFICE IN 2013 TO GET INFORMATION FROM THOSE WHO ACTUALLY DO THE WORK AND KNOW FIRST-HAND WHAT PROBLEMS OR ISSUES SHOULD BE LOOKED AT IN ORDER TO IMPROVE THE AGENCY. THIS WAY IT CAN MAKE THEIR JOB MORE EFFICIENT OR PROVIDE BETTER WAYS OF SERVING THE PUBLIC. THEREFORE, SHERIFF LEEPER WANTED TO MEET DIRECTLY WITH REPRESENTATIVES FROM ALL AREAS OF THE ORGANIZATION, WITHOUT SUPERVISORS PRESENT, TO LISTEN TO THEIR THOUGHTS. SEVERAL OF THE COMMITTEE MEMBER'S SUGGESTIONS OVER THE PAST YEAR HAVE BEEN IMPLEMENTED AND MANY OTHERS ARE BEING EXPLORED. THERE HAVE BEEN LONG STRIDES IMPROVING THE AGENCY AND MUCH IS APPRECIATED.



# New Airboat



THE NASSAU COUNTY SHERIFF'S OFFICE HAS ADDED AN AIRBOAT TO ITS AGRICULTURE AND MARINE UNIT. THESE BOATS CAN BE USED IN SEARCH AND RESCUE MISSIONS, ESPECIALLY IN MARSHY AREAS AROUND NASSAU COUNTY OR PLACES WHERE THE WATER IS SHALLOW. FOR EXAMPLE WE HAVE HAD INCIDENTS HERE IN NASSAU COUNTY WHERE A PLANE HAS CRASHED INTO THE MARSH OR A BOAT HAS RUN AGROUND AND WAS DAMAGED OR GOTTEN STUCK DURING LOW TIDE MAKING IT DIFFICULT TO RESCUE PASSENGERS. WITH OUR AIRBOAT WE CAN IMMEDIATELY ASSIST THOSE WHO BECOME STRANDED. IN ADDITION, AIRBOATS GLIDE ABOVE THE WATERLINE AND THAT ALLOWS THEM TO DO LITTLE TO NO DAMAGE TO THE ENVIRONMENT. THE PROPELLER IS ALSO ABOVE THE WATERLINE MAKING THEM MORE ECO-FRIENDLY. THEY CAN EASILY MANEUVER THROUGH SHALLOW SWAMPS, MARSHES, CANALS, RIVERS, AND, LAKES. RECENTLY WE SAW AIRBOATS BEING USED TO HELP WITH RESCUE OPERATIONS IN SOUTH FLORIDA AFTER HURRICANE IAN.



# New Bike Unit



ON OCTOBER 19 NCSO OFFICIALLY “ROLLED OUT” ITS NEW BICYCLE UNIT. OVER THE SUMMER THESE DEPUTIES HAD THE CHANCE TO TRAIN WITH JSO TO GET FAMILIAR WITH USING A BIKE WHILE ON PATROL. THE BICYCLE PATROL UNIT CONSISTS OF SPECIAL OPERATIONS/ COMMUNITY AFFAIRS DEPUTIES. THE UNIT WILL BE USED TO OCCASIONALLY PATROL BICYCLE PATHS AND TRAILS AROUND NASSAU COUNTY AND WILL ALSO BE USED FOR SPECIAL EVENTS. THE USE OF A PATROL BICYCLE ALLOWS DEPUTIES TO BECOME MORE MOBILE, VISIBLE, AND APPROACHABLE TO MEMBERS OF THE COMMUNITY. # Gun Range



NCSO HELD A RIBBON-CUTTING CEREMONY FOR ITS NEW TRAINING FACILITY. THE 40-ACRE PUBLIC SAFETY TRAINING COMPLEX BEHIND SANDHILL RECYCLE CENTER ON C.R. 108 HAS BEEN IN THE WORKS FOR YEARS, AND THE FIRST PHASE OF THE PROJECT INVOLVING THE INITIAL INFRASTRUCTURE, GUN RANGES, RANGE TOWERS, BATHROOMS AND A TEMPORARY PARKING LOT IS NOW COMPLETE. NASSAU COUNTY SHERIFF BILL LEEPER FIRED THE FIRST SHOT AT THE RANGE. AS CALLS FOR LAW ENFORCEMENT AND FIRE AND RESCUE SERVICES INCREASE, A TRAINING FACILITY CAPABLE OF MATCHING THE FUTURE PUBLIC SAFETY NEEDS IS REQUIRED.

WITH PHASE ONE COMPLETE, PHASE TWO OF THE PROJECT WILL CONSIST OF A TRAINING CLASSROOM BUILDING.

EVENTUALLY THE COMPLEX WILL ALSO INCLUDE A FIRE TRAINING TOWER, A CANINE TRAINING AND TRACKING AREA, AND A SPECIAL RESPONSE TEAM OBSTACLE COURSE.

# State ID Cards

OUR NEW INMATE STATE ID CARD SERVICE IS A PART OF NCSO'S REENTRY PROGRAM. OUR GOAL IS TO PROVIDE RESOURCES TO INMATES SO THEY CAN BECOME BETTER CITIZENS TO OUR COMMUNITY. IT HELPS INMATES GAIN EMPLOYMENT, SCHOOLING, AND FURTHER ASSISTS IN REDUCING RECIDIVISM. WHEN PEOPLE ARE INCARCERATED, ESPECIALLY FOR A LONG PERIOD OF TIME, THE GOVERNMENT ID THAT THEY ORIGINALLY HAD BEFORE THEY ENTERED PRISON MAY NO LONGER BE VALID AND THAT SMALL PIECE OF PLASTIC THAT MANY TAKE FOR GRANTED IS NEEDED ALMOST DAILY IN OUR LIVES. A FEW WEEKS AGO, WE ASKED THE TAX COLLECTOR'S OFFICE TO HELP WITH THIS SERVICE AND IT WAS HAPPY TO ASSIST US IN PROVIDING THIS SERVICE TO THE NASSAU COUNTY JAIL INMATES. THE FUNDS FOR THIS SERVICE WAS PROVIDED BY THE INMATE WELFARE FUND AND NOT TAX PAYER DOLLARS.



# ELITE

THE NASSAU COUNTY SHERIFF'S OFFICE IS TASKED WITH HOUSING INDIVIDUALS WHO HAVE BEEN SENTENCED BY THE COURT TO SERVE UP TO ONE YEAR IN THE DETENTION FACILITY. A NUMBER OF THESE INMATES ARE REPEAT OFFENDERS THAT COME IN TO THE CRIMINAL JUSTICE SYSTEM OVER AND OVER AGAIN. OUR GOAL IS TO PROVIDE THEM WITH THE NECESSARY SKILLS AND CONFIDENCE SO THEY CAN LEAD A BETTER LIFE OUTSIDE OF JAIL AND NOT BURDEN THE SYSTEM BY WINDING BACK BEHIND BARS.

SHERIFF BILL LEEPER HAS AUTHORIZED A NEW PROGRAM DESIGNED JUST FOR WOMEN CALLED ELITE (EDUCATION LEADS INTO EXCELLENCE) TO HELP THOSE INDIVIDUALS BECOME PRODUCTIVE MEMBERS OF SOCIETY.

ELITE'S MISSION IS TO ASSIST OFFENDERS/EX-OFFENDERS TO SUCCESSFULLY RE-INTEGRATE BACK INTO THE COMMUNITY WITH THE STRENGTH OF CHARACTER, EDUCATION AND TRAINING TO SERVE AS PRODUCTIVE MEMBERS OF SOCIETY WHO WILL NOT RE-OFFEND.

ELITE'S VISION IS TO PROVIDE SERVICES, SUCH AS MENTORING, EDUCATIONAL AND EMPLOYABILITY SKILLS OPPORTUNITIES, JOB TRAINING & PLACEMENT SERVICES, AND EMOTIONAL/SOCIAL COUNSELING TO ADDRESS THE MULTIPLE AND LAYERED ISSUES OF INMATES & EX-OFFENDERS SO THEY MAY SUCCESSFULLY CHANGE THEIR LIVES AND REDUCE THEIR RATE OF RECIDIVISM.

ELITE'S PROGRAM'S GOALS ARE TO OFFER INTAKE ASSESSMENT & PLANNING, EDUCATION, CAREER & EMPLOYMENT, GOAL PLANNING, COUNSELING, PARENTING CLASSES, SUBSTANCE ABUSE EDUCATION, SUPPORT GROUPS AND EMPLOYABILITY SKILLS WORKSHOPS. ELITE WILL ALSO PROVIDE GED TUITION AND TESTING FEES WHEN POSSIBLE TO STUDENTS SEEKING TO EARN THEIR GED.

OTHER PROGRAMS THAT ARE OFFERED TO ALL MALE INMATES AT THE DETENTION FACILITY ARE ALCOHOLICS ANONYMOUS, THE GODLY MAN, AND COURAGE TO CHANGE PROGRAM.



# Personal Trainer Program

NASSAU COUNTY INMATES TRAINED FOR ABOUT SIX WEEKS TO BECOME ISSA CERTIFIED PERSONAL TRAINERS. ONE OF THE REQUIREMENTS FOR THESE INMATES BECOMING CERTIFIED PERSONAL TRAINERS WAS THAT THEY NEED TO BE AED/CPR CERTIFIED SO WE PARTNERED WITH FIRST COAST CPR AND THE CLASS WAS A SUCCESS. THROUGHOUT THE SIX WEEKS, THERE WERE MANY STUDY SESSIONS TO ENSURE THESE INMATES PASSED WITH FLYING COLORS. IT SHOULD BE NOTED THAT THIS PROGRAM WAS PAID FOR BY THE INMATE WELFARE FUND.



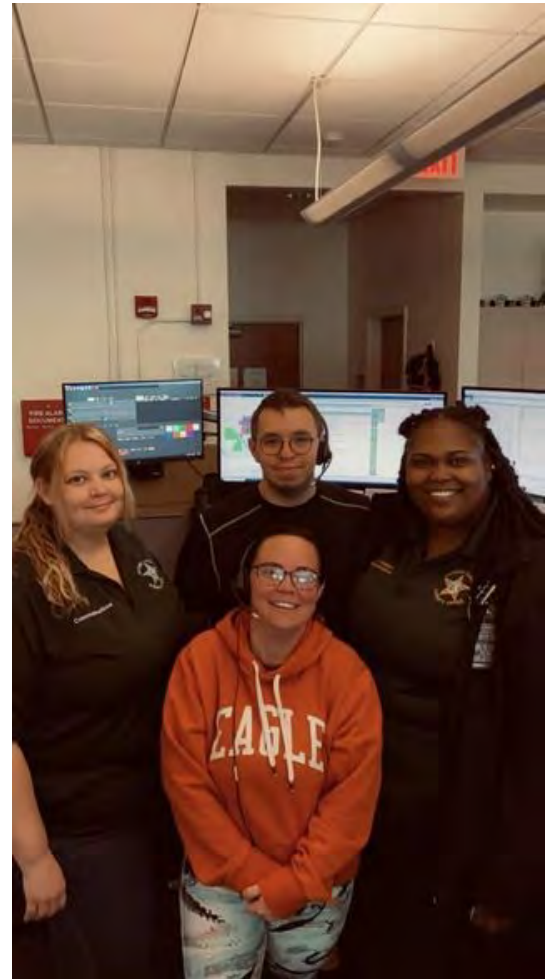
# Bloodhounds

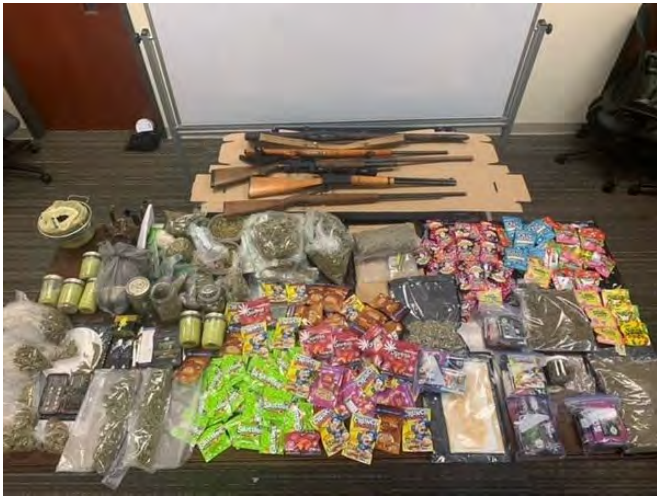


# First Find

# Drug Arrests



ON APRIL 19TH WE ARRESTED 34-YEAR-OLD JAKE LEE CLEVELAND AFTER OUR AGENCY'S NARCOTICS DETECTIVES CONDUCTED A SEARCH WARRANT AT HIS HOME. CLEVELAND ALREADY HAD TWO ACTIVE ARREST WARRANTS IN NASSAU COUNTY FOR SELLING MARIJUANA AND TWO COUNTS OF SALES OF A CONTROLLED SUBSTANCE. DURING THE SEARCH DETECTIVES LOCATED LARGE QUANTITIES OF A "GREEN LEAFY SUBSTANCE" IN SEVERAL AREAS ON THE PROPERTY. WHILE IN THE KITCHEN DETECTIVES SPOTTED SEVERAL BLACK BAGS AND CARDBOARD BOXES CONTAINING DOZENS OF THC CANDIES. IN TOTAL 169 PACKAGES OF THC CANDIES WERE SEIZED. SEVERAL FIREARMS WERE ALSO LOCATED IN A SAFE. HE WAS BOOKED INTO THE NASSAU COUNTY JAIL. HE IS CURRENTLY FACING CHARGES OF TRAFFICKING MARIJUANA, POSSESSION WITH INTENT TO DISTRIBUTE MARIJUANA, POSSESSION OF A CONTROLLED SUBSTANCE, OPERATION OF A DRUG HOUSE, SIX COUNTS OF POSSESSION OF A FIREARM AND AMMUNITION BY A CONVICTED FELON, AND ONE COUNT OF POSSESSION OF DRUG PARAPHERNALIA WITH RESIDUE.





30-YEAR-OLD CORDELL SHELBY WAS ARRESTED ON STATE ROAD 200 IN FERNANDINA BEACH AFTER NCSO INVESTIGATORS UNCOVERED COCAINE, ECSTASY, AND OTHER DRUGS IN HIS VEHICLE DURING A TRAFFIC STOP. IN TOTAL 83 GRAMS OF COCAINE, 7 GRAMS OF MDMA, AND 80 GRAMS OF MARIJUANA WERE FOUND. SHELBY ALSO HAD A YOUNG CHILD PRESENT IN THE BACKSEAT OF HIS CAR. SOME OF SHELBY'S CHARGES INCLUDE POSSESSION OF COCAINE AND POSSESSION OF A CONTROLLED SUBSTANCE WITH THE INTENT TO SELL. THE SUSPECT WAS BOOKED INTO THE NASSAU COUNTY JAIL.

# Drug Busts



A DRUG HOUSE WAS SHUT DOWN BY NCSO AND FBPD. NOVEMBER 9TH OUR SPECIAL RESPONSE TEAM AND NARCOTICS UNIT SERVED A SEARCH WARRANT TO A HOME ON NASSAU LAKES CIRCLE IN FERNANDINA BEACH. SEVERAL ARRESTS WERE MADE.



ON OCT 28TH 2022 NCSO DEPUTIES SERVED A SEARCH WARRANT TO A RESIDENCE ON LONNIE CREWS ROAD IN FERNANDINA BEACH. SEVERAL ARRESTS WERE MADE.



# Operation Heavyweights

A MONTHS LONG, MULTI-AGENCY INVESTIGATION NAMED "OPERATION: HEAVYWEIGHTS" HAS RESULTED IN 54 ARRESTS AND THE SEIZURE OF HUNDREDS OF POUNDS OF ILLEGAL NARCOTICS.

THE ARRESTS WERE MADE BETWEEN APRIL TO AUGUST OF 2022. OF THOSE ARRESTED, 25 PEOPLE WERE FROM FERNANDINA BEACH, 11 WERE FROM YULEE, FIVE WERE FROM GEORGIA, FIVE WERE FROM HILLIARD, FIVE WERE FROM CALLAHAN, TWO WERE FROM JACKSONVILLE AND ONE WAS FROM LAKE CITY. COMBINED, ABOUT 223 CHARGES WERE FILED AGAINST THE SUSPECTS. 3.5 POUNDS OF FENTANYL WERE SEIZED IN ADDITION TO 25 ILLEGAL GUNS, 380 POUNDS OF MARIJUANA AND THC PRODUCTS, 6.5 POUNDS OF METH, 3 POUNDS OF COCAINE, SMALLER AMOUNTS OF OTHER DRUGS, INCLUDING HEROIN, AND \$72,000 WORTH OF ASSETS.

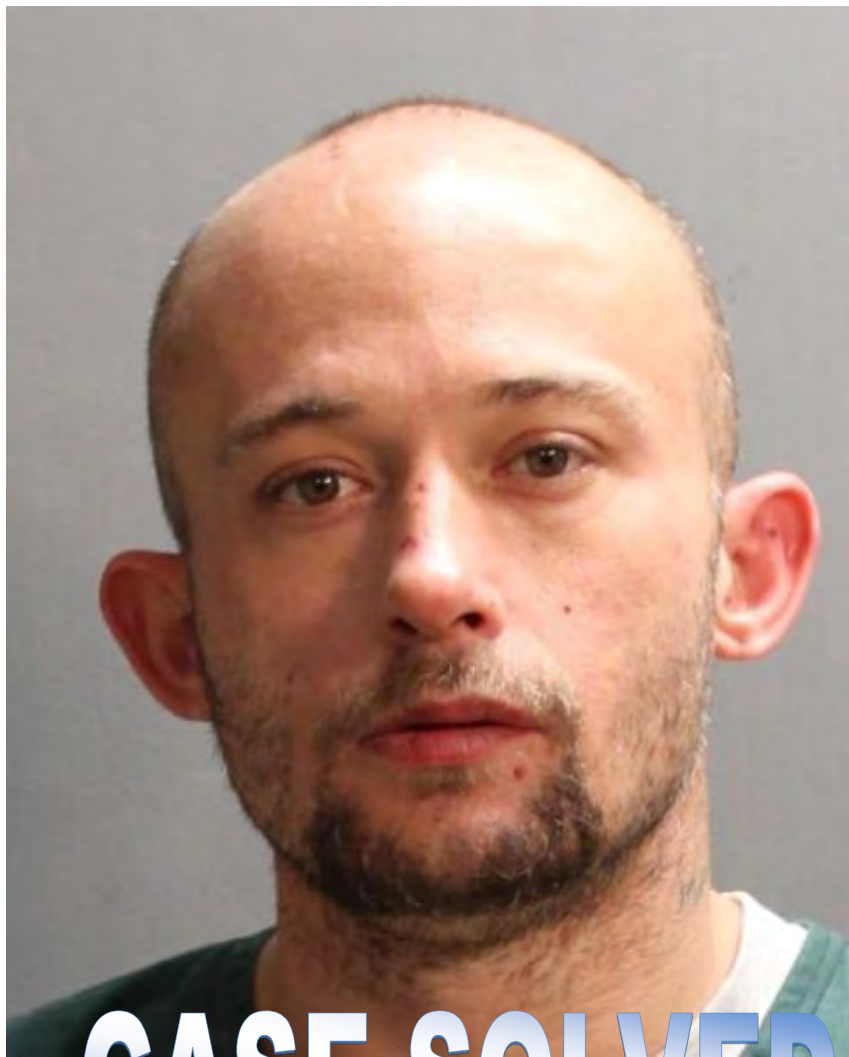

# Operation Keystroke

IN SEPTEMBER 2022, WE CONDUCTED OPERATION KEYSTROKE, WHICH WAS FOCUSED ON THOSE WHO SEARCH THE INTERNET PRAYING ON CHILDREN AND SOLICITING SEX. DETECTIVE HEATHER ROJAS DID AN OUTSTANDING JOB PLANNING AND COORDINATING THE OPERATION, WITH NARCOTICS, CID, SRT, AND CORRECTIONS AMONG OTHERS, AS WELL AS SEVERAL OTHER LAW ENFORCEMENT AGENCIES (FBI, FDLE, ST JOHNS SO, FERNANDINA BEACH PD, PANAMA CITY BEACH PD, NCIS, STATE ATTORNEY'S OFFICE AND US ATTORNEY'S OFFICE). THE 4-DAY OPERATION NETTED 11 ARRESTS FOR SOLICITING UNDERCOVER DETECTIVES PRETENDING TO BE A 13-14 YEAR OLD CHILD. TEN OF THOSE ARRESTED ACTUALLY TRAVELED TO AN UNDERCOVER LOCATION THINKING THEY WERE GOING TO HAVE SEX WITH A CHILD, BUT WERE MET WITH LAW ENFORCEMENT AND TAKEN INTO CUSTODY. ONE WE ARRESTED ON A WARRANT. IT'S SCARY TO KNOW THERE ARE DEVIANTS OUT THERE LIKE THIS, SO PLEASE MAKE SURE YOU KEEP TRACK OF WHAT YOUR CHILDREN ARE DOING AND WHO THEY ARE TALKING TO, ESPECIALLY ON-LINE.







## CASE SOLVED

NCSO'S DETECTIVE CARTER RECENTLY SOLVED A 2019 SEXUAL BATTERY USING CODIS (COMBINED DNA INDEX SYSTEM), A COMPUTER SOFTWARE PROGRAM FUNDED BY THE FBI WHICH ALLOWS FORENSIC LABORATORIES TO CREATE SEARCHABLE DATABASES OF AUTHORIZED DNA PROFILES. ON JUNE 29, 2022, NCSO RECEIVED A CALL OF A PERSON, DECEASED AT THE BOTTOM OF A POOL ON FRANKLIN RD IN HILLIARD. THE EVIDENCE ON SCENE SUGGESTED THAT AN INDIVIDUAL ATTEMPTED TO MAKE ENTRY TO THE HOUSE DUE TO BLOODY HAND PRINTS ON THE REAR GLASS DOOR. DETECTIVE CARTER WAS ABLE TO IDENTIFY THE INDIVIDUAL IN THE POOL AS JIMMIE LEE BALDWIN. DETECTIVE CARTER TOOK A SAMPLE OF BALDWIN'S BLOOD FROM THE DOOR AND SENT IT OFF TO ENSURE THAT WE DIDN'T HAVE ANOTHER INDIVIDUAL THAT COULD HAVE LEFT THE HAND PRINTS. IN DECEMBER OF 2022 THE RESULTS CAME BACK FROM CODIS AS A MATCH FOR THE SUSPECT IN A SEXUAL BATTERY THAT OCCURRED IN NASSAU COUNTY IN JUNE OF 2019, THAT INITIALLY HAD NO SUSPECT INFORMATION. THE VICTIM WAS CONTACTED AND ADVISED THAT THE SUSPECT WAS JIMMIE BALDWIN WHO IS NOW DECEASED AND THAT THE DNA RETURNED MATCHED THE DNA RECOVERED FROM THE 2019 SEXUAL BATTERY.

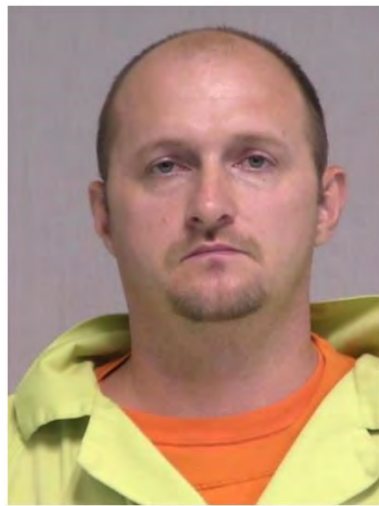
# Ratliff Road Shooting



ON DECEMBER 27, 2022, NCSO RESPONDED TO THE INTERSECTION OF RATLIFF ROAD AND WOODBRIDGE DRIVE IN RESPONSE TO A PERSON SHOT. UPON ARRIVAL DEPUTIES LOCATED A FEMALE WHO HAD BEEN SHOT IN THE ARM SITTING IN HER VEHICLE IN FRONT OF THE FORMER FIRE STATION LOCATED ON RATLIFF ROAD. A WITNESS CALLED 911 AND TOLD DISPATCH THE VICTIM WAS SHOT BY HER 81-YEAR-OLD FATHER. THE VICTIM TOLD DEPUTIES HER FATHER'S NAME IS ROBERT HALL. THE SUSPECT WAS LOCATED AND DETAINED BY NCSO. DEPUTIES LEARNED THAT HALL AND HIS DAUGHTER GOT INTO AN ARGUMENT AND AT ONE POINT, HALL REACHED FOR HIS .38 CALIBER SMITH & WESSON REVOLVER IN A SIDE TABLE NEAR HIS CHAIR AND FIRED MULTIPLE SHOTS. AT LEAST TWO SHOTS HIT A WALL IN THE HOME AND A THIRD SHOT HIT THE VICTIM IN THE SHOULDER. SHE WAS TAKEN TO THE HOSPITAL WITH NON-LIFE THREATENING INJURIES. HALL WAS ARRESTED AND CHARGED WITH ATTEMPTED MURDER.



# Road Rage Incident

TWO MOTORISTS ALLEGEDLY SHOT AT EACH OTHER DURING A ROAD RAGE INCIDENT, STRIKING EACH OF THEIR DAUGHTERS WHO WERE ALSO IN THEIR CARS.

“WHEN I FIRST HEARD ABOUT IT HAPPENING, I THOUGHT OF THE MOVIE ‘DUMB AND DUMBER,’” SAID SHERIFF BILL LEEPER.

FRANK ALLISON AND WILLIAM HALE GOT INTO A HIGH-SPEED “CAT AND MOUSE” FACEOFF ON THE HIGHWAY INVOLVING SUDDEN STOPS, OBSCENE GESTURES AND A WATER BOTTLE THROWN AT ONE CAR. SUDDENLY, GUNFIRE ERUPTED.

ALLISON OPENED FIRE ON HALE’S CAR AND HIT A 5-YEAR-OLD GIRL IN THE LEG. COPS SAY HALE FIRED BACK AS MANY AS EIGHT TIMES AND HIT A 14-YEAR-OLD GIRL IN THE BACK. ONE OF THE WOUNDED GIRLS CAN BE HEARD YELLING IN POLICE BODYCAM FOOTAGE OF THE INCIDENT.

BOTH OF THE DRIVERS WERE CHARGED WITH ATTEMPTED MURDER.

“THERE COULD HAVE BEEN TWO DEAD KIDS BECAUSE OF TWO STUPID GROWN MEN,” SHERIFF LEEPER SAID.

IF CONVICTED OF THE ATTEMPTED MURDER CHARGES, EACH DAD COULD FACE UP TO 15 YEARS IN PRISON.

NCSO DEPUTY PHILIP HAGAN RECEIVED A LIFE SAVING AWARD, BECAUSE WITHOUT HIS QUICK ACTIONS THE 14-YEAR-OLD WOULD NOT BE HERE TODAY.

# Halloween Safety



EVERY YEAR OUR INVESTIGATORS PLACE THESE RED SIGNS OUT TO ALERT TRICK-OR-TREATERS AND THEIR FAMILIES TO STAY AWAY FROM HOMES OF SEXUAL PREDATORS. AS A REMINDER SEX OFFENDERS IN NASSAU COUNTY ARE NOT PERMITTED TO PARTICIPATE IN ANY HOLIDAY EVENT INVOLVING CHILDREN, INCLUDING DISTRIBUTING CANDY ON HALLOWEEN OR WEARING COSTUMES THAT MIGHT ATTRACT CHILDREN.

TRICK-OR-TREATING IN DOWNTOWN FERNANDINA
